## **COVID-19 Liability Release Waiver**

**IMPORTANT: Please read the following carefully! Fill in below.**

Due to the outbreak of the novel Coronavirus (COVID-19), CYO Day Camp is doing everything we can to protect our students, families, our community and our staff. To this extent, CYO will be following the Center of Disease-Control (CDC) with regard to social distancing practicing and sanitation.

I, \_\_\_\_\_, acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing.

I further acknowledge that the CYO Day Camp cannot guarantee that myself or my child(ren) will not become infected with the Coronavirus/COVID-19. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of myself and others, including, but not limited to, program staff, and other players and their families,

I voluntarily seek services provided by CYO Day Camp and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19. I acknowledge that I must comply with all set procedures to reduce the spread.

The CYO Day Camp will be adhering to the following enhanced procedures to prevent the spread of COVID-19:

Our program staff will...

- Do a temperature check before entering the building and ensure that it is below 100.4F.
- Clean/Disinfect frequently touched surfaces thoroughly and at regular intervals.
- Wear our masks at all times.
- Maintain a safe distance at all times.
- Accommodate a limited number of campers to ensure physical distancing.
- No outside visitors or sources of any kind will be allowed in our building.
- Provide sanitizers in the class area and other locations within the premises.

We are requesting that each of our students, please...

- Allow us to check their temperature before entering the premises to ensure it is below 100.4F

- Wear a face mask at all times within the building and within building limits to ensure the safety of other families.
- Maintain a safe distance from others at all times.
- Wash/Sanitize their hands when entering, throughout the day and while exiting the classroom.

\_\_\_\_ My family has not traveled to a highly impacted area within the United States of America in the last 14 days.

\_\_\_\_ I do not believe any member of my household has been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.

\_\_\_\_ Any member of my household has not been diagnosed with Coronavirus/COVID-19 and not yet cleared as non-contagious by state or local public health authorities.

\_\_\_\_ I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.

By signing below, I agree to each statement above and release the CYO from any and all liability for the unintentional exposure or harm due to COVID-19.

I understand that this release discharges the CYO Day Camp from any liability or claim that I, my family, or any personal representatives may have against the CYO with respect to any exposure to the novel Coronavirus (COVID-19) that may arise from, or in connection to, any services received from CYO. This liability waiver and release extends to the CYO Day Camp together with all owners, partners, and employees.
